Year 10 GCSE RE exams

The purpose of this letter is to share important details regarding the upcoming GCSE RE exams.

DATES OF THE GCSE RE EXAMS (held in the Leisure Centre)

There are specific exam protocols to follow e.g. only writing in black ink. Students are aware of these due to the PPE in December 2023 and information shared in class. I will write again with final reminders about these at the start of next term.

GCSE RE Full Course Exams:

Paper 1 Tuesday 13th May (AM) (1hr 45mins)

This assesses Christian Beliefs and Practices; Islamic Beliefs and Practices

Paper 2 Wednesday 21st May (PM) (1hr 45mins)

This assesses Themes – Religion, Peace and Conflict; Relationships and Families; Religion and Life; Religion, Crime and Punishment

GCSE RE Short Course Exam

Wednesday 21st May (PM) (1hr 45mins)

This assesses Christian Beliefs; Islamic Beliefs; Religion, Peace and Conflict; Relationships and Families

REVISION MATERIALS

All Year 10 students will receive their revision folders during their lessons this week. These include the relevant GCSE RE specification, every single past paper question, and other revision materials such as knowledge quizzes for all the units being assessed. These folders should supplement other materials Year 10 students have been directed to, including their exercise books, Google Classroom and online revision videos.
